India III 54th Year Reunion, Sept. 2017 St. Paul, Minnesota

India III returned to their campus training site, the University of Minnesota—St. Paul campus fifty-four years later (1963-2017)! A group of nine RPCV's and two spouses joined together for a three day reunion from Sept 13-16 hosted by Minnesotans, Donna Anderson and John Chromy.



The weather was beautiful, the hospitality exceptional and the camaraderie typical of India III—warm and comfortable. Donna Anderson, life-long resident of Minnesota (a true ambassador for St. Paul) was our main organizer. She kept us busy, on-schedule, on the-right-roads most of the time, and very well fed!

We gathered together at Donna's house on Wednesday afternoon Sept 13 for snacks and then dinner. Mary and Harry who had driven from Michigan (ferrying across Lake Michigan) went to the airport late that afternoon to pick-up Joe Bette and Ken and Maria Lyvers. Luck was with us—without even a contact by cell-phone, we met-up with both parties and whisked everyone back to Donna's House. In the meantime, Larry Brown drove-in from Colorado in his new RAM truck (very impressive) and Jack Slattery arrived after traveling to two weddings on the east coast and having been on-the-road for a few weeks. His wife Cynthia joined us for some events,

but was staying with her 98-year-old mother! John Chromy had a board meeting at his old elementary school and arrived just as we started dinner. Connie Hankins had arrived earlier in the day; her brother bringing her in from the airport. So we were finally all together!



We met at Donna's home in an older residential area of St. Paul. Her flower gardens both on the street and in the back yard were




After breakfast, Connie and Donna joined us to guide us to our appointment with Mary Buschette, the Director of Alumni & Constituent Relations in the College of Food, Agriculture and Natural Resources. We learned about the changes on-campus since our days there. At this time, Donna shared a wealth of information that she had gleaned from her own files (India training syllabus, case studies, and discussion questions) and from the Campus Archives about our training program in 1963. From the final report of our training program, prepared by staff---"India trainees were a very heterogeneous group. They varied widely in age (from 19-65), intelligence, experience and education....The India group had bonds and customs that no other



training group had demonstrated. Probably the most observable of these was the habit trainees acquired at Puerto Rico of running everywhere." We walked over to the area where Dexter Hall once stood (green grass) and even had ice cream at the newly expanded Student Center

(where we sang along with Guy Clark, Bob Geissel and Harry Andrews on instruments). While in our meeting with Mary Bruchette, she mentioned the Norman Borlaug



Other Notes: While at the reunion, Donna shared a copy of a small book that **Carolyn Banks** created to document her trip to India to distribute Roger's ashes in the Ganga. The little book, "Tigers, Temples, and Marigolds" contains poems and descriptions of the various cities that she visited on the trip in January-February 2013 after Roger died. It includes pictures of placing his ashes in the Ganges River in Varanasi with the sunset in the background!

When Donna was talking with **Pat Cantlon's** sister it was agreed that we would try to contact Pat by phone when we were together....Well, Joe Bette tried to do so. On the first try they were disconnected and Joe never knew if Pat was aware of who was calling. But on the second try, the next morning, Pat answered and mentioned that Joe had called the night before! So he knew who had tried to call. But on this attempt the quality of the line

was so bad that although Joe could hear, Pat could not. Thereafter they never did connect. Pat mentioned that he was going into surgery that afternoon for macular degeneration issues.

Lastly, sad news—Donna did a search on the internet for **John Reid** in the Columbus Ohio newspapers and came across his obituary. He died in 2008 while in the John Hopkins Hospital (so he may have been seriously ill). It mentions his two daughters and a son, but no mention of a wife. His career was in hospital administration. John Edward Reid--from the Columbus Dispatch

REID John Edward Reid, 67, died a peaceful death surrounded by his children on Wednesday, January 9, 2008 at Johns Hopkins University Medical Center in Baltimore, MD. He was born March 25, 1940 in Laurelville, OH. He was a wonderful father who raised three healthy children and always gave a helping hand to family and friends in need. An undergraduate degree from Ohio State University and a Master's degree from George Washington University allowed John to enjoy a successful 37 year career in the hospital administration field. Spent two years as a Peace Corps volunteer in India, served his country during the Vietnam War, and traveled to numerous overseas countries as a young man. He was a member of multiple civic, fraternal, and professional organizations throughout his career. Hobbies included spending time with family, watching Ohio State athletics, and following the real estate market. Survived by son, Aaron Reid; daughters, Beth Reid and Hailey Scott; and sister, Janet (Richard) Biery. He was preceded in death by his parents George and Audrey Reid. Memorial service will be held at 3 p.m. on Saturday, January 19, 2008 at the FRANK E. SMITH FUNERAL HOME, 405 N. Columbus St, Lancaster, OH 43130 with Pastor Mark Eaton officiating.
